a) Mark Roe requested information regarding FF's reserve policy, whether there was one and if so could it be visible to residents.

Mark Prangell explained that this had indeed recently been resolved in FF meetings, that FF propose to keep 2 year's worth of running costs (approx £2500) plus another £1000 in reserve, giving a total of £3500. Anything above that plus anything made during the year can go towards funding requests.

b) Paul Samain suggested that the village should be kept informed of everything to do with FF.

c) Andy Chattell thanked Wendy Simmons and Mark Roe for the donation of a screen and suggested the possibility of funding a projector. Margaret Samain suggested the possibility of film nights in the Village Hall.

d) Andy Chattell also thanked Wendy Simmons and Mark Roe for providing assistance with selecting the very good PA system that has already been put to use and will be a great asset to future events.

e) Ian Seager congratulated FF for their efforts this year and raised several points : **see attachment 4**

(With regard to Ian's feeling about fete not being so children-oriented this year there followed a brief discussion including Mark Prangell and Neil Leech regarding many activities being precluded due to high insurance costs. Mark Prangell also stated that FF had already discussed this point at a meeting just after the fete and that there were ideas already in hand about making next year's fete more interesting to children.
